1. General information

Contracting Authority OMIŠPLAST d.o.o. is implementing the project "Production Expansion", granted by Norway Grants Program "Business Development and Innovation Croatia" and have to aim to buy Big profile Circular saw.

Tender procedure will be held in accordance with Procurement procedure for Entities not subject to Public Procurement Act by the publication of the procurement notice which is available at web page www.omisplast.hr.

In accordance to Procurement procedure for Entities not subject to Public Procurement Act, Contracting Authority have obligation to act with the principles of avoiding conflicts of interest. This understand that persons involved in implementation and management, including acts preparatory thereto, audit or control shall not take any action which may bring their own interests into conflict. Where such a risk exists, the person in question has to be excluded from any action which could be in conflict of interest. Conflict of interests exists also for situation where in process are included family and related company.

2. Procurement subject information

Subject of this procurement is Big profile circular saw machine.

This Open tender will understand procurement for machine: Big profile Circular saw - **Procurement number 2023/363972-05**

The procurement subject includes machine delivery, machine installation and employee education for work with machine. Offered Machine have to be new.

3. Technical specification of Big profile Circular saw

The technical specification of the Big profile Circular Saw is described below.

Product types, standards or any other characteristic mentioned in specification will be reference but will understand "equivalent" characteristic of supplier.

Proof of equivalence is delivered by the Tenderer within the offer, by appropriate means, such as technical specifications, technical data and similar. The proof of equivalence will be basis for evaluating whether the offered machine have the prescribed features.

Specification:

- two circular saws
- working length at least 5,5 m
- circular saw diameter at least 470 mm
- motor power: at least 3,5 kW
- label printer with machine
- Display with Touch
- Rpm at least 2000/min
- Vacuum cleaners for each saw head with minimum power 2 kW
- Manual Saw tilt at least 22.5°
- Limiter for short cutting measures
- Saw positioning accuracy +/- 1 mm per meter or better
- extension with rollers for profile material
- profile/material raisers
- Warranty at least 12 months

Offer need to include additional set of saws.

4. Delivery

Place of delivery will be manufacturing address of OMIŠPLAST d.o.o. company: **Omiš, Vrisovci 17, Croatia.**

Delivery has to be up to **120 days** after Purchase Contract signing.

Contract will be based on tenderer offer and technical specification in this tender. In case that tenderer make offer with better condition than requested in Tender, better condition for Contracting authority Omišplast d.o.o. will be part of Contract.

After finishing tender, company will analyze offers from potential supplier and make decision in next 15 days. After decision, Omišplast d.o.o. will inform tenderer about decision and will prepare Contract to tenderer who win the tender.

Contract have to be signed 15 days after final decision to tenderer.

5. Education

After machine delivery and installation, Tenderer will ensure education for work with machine. Education has to be on Croatian language.

6. Warranty

Warranty has to be at least **12 months** after installation of machine.

Tenderer have to be ready to react in **12 hours** after warranty request and have at least 2 certified technician for warranty request. Warranty has to be supported on Croatian language and service company/partner have to be capable effectively communicate in Croatian, to avoid possible misunderstanding.

7. Selection and Award criteria

Award will be based on the **most commercial advantageous Offer (MCAO)** and will be based on:

- N – number of technicians – Number of technicians will be participating in assessment with 10% and will be calculated as: (2 technician / Number of tenderer technicians)
- P – Price – Price will be valued with 90% in assessment. Price will be calculated as: (price offer / Average price offer)

Calculation will be: **$MCAO = (2/N)*10\% + (P/average\ price)*90\%$**

Lowest MCAO will be Awarded.

Tenderer have to proof technical specification of Big profile Circular saw and have to deliver machine in accordance with offer. All expences have to be included in offer and offer with additional expences will not be accepted.

Related document has to be applied by tenderer.

8. Tendering

Offer delivery

Tenderer have to deliver offer with Application Form in Appendix and document which proof compliance with Tender request. Tenderer have to apply price with and without VAT.

Number of certified technicians will be confirmed with their certificate with requested reaction on warranty request. Requested warranty reaction will be calculated based on car distance.

In case of additional question, Tenderer should send them in writing to OMIŠPLAST d.o.o., Vrisovci 17, 21310 Omiš, Croatia or by e-mail: omisplast.projekt@gmail.com at least 4 days

before the deadline for submission of tenders. The Contracting Authority must reply to all tenderers' questions at least 24 hours before the deadline for submission of tenders.

Deadline for submission of tenders

Deadline for submission offer is end of day August 7th 2023, Croatia local time by e-mail: omisplast.projekt@gmail.com.

Any tender received after this deadline will not be considered.

Payment

Final payment has to be after signing acceptance from Omišplast d.o.o. Acceptance will be after all activities are completed from Tenderer (delivery, education, test of machine) and have to be done 15 days after delivery. Final payment has not been less than 20% of offer.

Other payment has to be not earlier of 10 days before machine delivery.

Tenderer have to deliver to Omisplast d.o.o. prepayment confirmation (prepayment invoice or warranty) after payment.

9. Other condition

Language of the procedure

All communications for this tender procedure and contract must be in English.

Warranty for offer, contracting and delivery

Tenderer have to deliver to company address warranty for offer, contracting and delivery (debenture or bank guarantee or direct payment to company IBAN HR4624070001500019932) which could be on Tenderer language in amount of 3.000€.

Warranty will be activated:

- If Tenderer don't accept and sign contract condition in accordance with Tenderer offer. In this case, Omisplast d.o.o. will offer Contract to next Tenderer
- If Tenderer don't deliver machine in accordance with Contract.

Warranty will be returned to tenderer after Acceptance test confirmation.
